On August 17th, 2025 Joe was asked to provide road closure signs for an incident in Slatedale located on Mountain Road. At that time, only three road signs were available. Manager Wade Marlatt said that more signs have been ordered and the problem has been taken care of.

PUBLIC COMMENT:

Tito Burgos Fire Chief of Emerald Fire Company wanted to thank Washington Township for the help received with a call over this past weekend. Washington Township has followed recommendations so this incident did not become a bigger issue.

Last month there was a fire in Slatington, and Washington Township sent out workers to help with getting the hoses back to the station.

Chairman Josh Friebolin thanked Tito for the fire company's service.

Tom Scully of Oakwood Lane had some comments and recommendations about Oakwood Lane. He was concerned about the stop sign that may be put in by Vista Drive and Oakwood Lane. There is grading in the area and with a stop sign in place it could become very dangerous especially in the wintertime.

Josh and Wade explained that the township has entered into a traffic study of the area but it has not started yet. Wade said that LTAP has been in communication, but they have not come back with dates and times. Josh thanked Tom for his comment.

Jeffrey Hewitt of Walnutport purchased a banner for the Hometown Heroes project with the Slatington Borough. His question was why the flag couldn't be placed in Slatedale. Josh said over a year and a half ago the plan that was approved was to have the flags placed in a row and not placed by individual houses. The flags were supposed to be placed by Route 873.

Jeffrey feels that the flags should be allowed to be placed in Slatedale. Josh thanked Jeffrey for his comment. Patty Ingles of the Times News gave an update that the banners have been ordered. No time frame has been mentioned of when the flags would be hung up.
